

I - GENERAL TERMS

1° - ADMISSION REQUIREMENTS

To be allowed to penetrate, to settle, and remain on the campsite, it is necessary to be authorized there by the manager or its representative. It has as an obligation to take care of the good behavior and the good order of the campsite like to the respect of the application of this rules of procedure.

The fact of remaining on the campsite of the BOLD COCK implies the acceptance of the provisions of this payment and the commitment to conform to it.

Any infringement will be able to involve the eviction of its author with recourse to the police force so necessary.

2° - FORMALITIES OF POLICE FORCE

Any person having to remain at least a night in the camp must as a preliminary present to the manager or to her representative her papers identity and fill the formalities required by the police force. The minors not accompanied by their parents will not be allowed that with an authorization written of those. The foreign nationals including the nationals of the Member States of the European Union and the States left to Economic space Europeans are held to fill out an individual record sheet of police force, formality required by the decree n° 46 - 1574 of the decree of June 30th, 1946... It to him will be given one "to leave - to pass control". This to leave - to pass could be claimed by the employees or the persons in charge, at any moment, either with the site, or with the passage of the car!

3° - INSTALLATION

The tent or the caravan and the related material must there be installed with the site indicated in accordance with the directives given by the manager or his representative.

The sites all being delimited and being numbered, no one will not be able to install or to move without the agreement of the manager, the sites being sufficiently large, the vehicles will have obligatorily to station on the indicated site.

4° - RECEPTION OFFICE

Opened 8:00 with 20:00.

One will find at the Reception Office all the information on the services of the camp, information on the possibilities of supply, the sporting installations, the tourist richnesses of the surroundings and various addresses which can prove to be useful. After 8 p.m. in season, it is always possible to contact the persons in charge of the camp or the night watchman of the reception or guardroom.

A book of complaints or a special box intended to receive the complaints is held with the provision of the users. The complaints will be taken into account only if they are signed, will be dated, as precise as possible and referring to relatively recent facts.

5° - ROYALTIES

The royalties are paid at the Reception Office. Their amount is the subject of one posting at the entry of the campsite and the Reception Office. They are due according to the number of nights spent on the ground and calculated midday to midday.

The users of the camp are invited to prevent the Reception Office of their departure as of the day before this one.

The campers intending to leave before the opening hour the Reception Office must carry out the day before the payment of their royalties.

6° - NOISES AND SILENCE

The users of the camp are urged to avoid all noises and discussions which could obstruct their neighbors.

The sound apparatuses must be regulated consequently, closings of doors and of trunk must be as discrete as possible.

The dogs and other animals should never be left in freedom. They should not be left with the camp, even locked up, in the absence of their Masters who of it are civilly responsible.

Silence must be total between 23heures and 7 hours 30.

The notebook of updated vaccination, will be required on arrival of the camper.

7° - VISITORS

After authorizebeing authorized by the manager or his representative, the visitors can be allowed in the camp under the responsibility of the campers who receive them.

If the visit lasts more than two hours, those are held with the payment of a royalty per visitor.

The cars of the visitors will have obligatorily to be parked on the carpark at the entry of the camp

All people remaining in the camp irregularly at the users will be liable to a double tax which will be added to the royalty exigible at the time from the departure.

The camper can receive visitors with the reception. If these visitors are allowed to penetrate in the campsite, the camper who receives them can be obliged to discharge a royalty, insofar as the visitor has access to the services and/or installations of the campsite. This royalty is the subject of one posting at the entry of the campsite and the Reception Office.

8° - CIRCULATION AND PARKING OF THE VEHICLES

Inside the camp the vehicles must run at a speed limit of 10 km/h.

Circulation is prohibited enters 23 hours and 7 hours 30.

In the camp only the vehicles can circulate which belong to the campers remaining there. The parking, strictly prohibited on the sites usually occupied by the shelters of camp-site, should not, moreover, block circulation, nor to prevent the installation of new arrivals.

9° - BEHAVIOR EAST ASPECT OF THE INSTALLATIONS

Each one is held to abstain from any action which could harm cleanliness, the hygiene and the aspect of the camp and of its installations, in particular medical.

It is interdict to throw waste water on the ground or in the gutters.

The "caravaneers" must obligatorily empty their waste water in the installations envisaged for this purpose.

The household refuse, waste of any nature, papers must be deposited in the dustbins.

Washing is strictly interdict apart from the vats envisaged with this use.

The spreading of the linen will be done if necessary with the common drier. However, it will be tolerated up to 10 a.m. near the shelter, in the condition that it is discrete and does not obstruct the neighbors. It will have to never be made starting from the trees.

The floral plantations and decorations must be respected. It is interdict with the camper to plant nails in the trees, to cut the branches, to make plantations.

It is not allowed either to delimit the site of an installation by average personnel, nor to dig the ground. Any degradation made with the vegetation, the fences, the ground or the installations of the camp will be the responsibility of its author.

The site which will have been used during the stay will have to be maintained in the state in which the camper has finds it at his entry in the places.

10° - SAFETY

) Fire A

Open fires (wood, coal, etc...) are rigorously prohibited. The stoves must be maintained in good state of operation and not be used under dangerous conditions.

The extinguishers are at the disposal of all. In the event of fire, to warn the direction immediately.

A case of help of first urgency is at the Reception Office.

B) Flight

The direction is responsible only for the objects deposited at the office, and has a general obligation of monitoring of the campsite. The camper keeps the responsibility for his own installation and must immediately announce to the person in charge the presence in the camp of any suspect person. Although guarding is assured, the users of the camp are invited to take the usual precautions for the safeguard of their material.

11° - PLAYS

No plays violent or awkward can be organized near the installations. The meeting room cannot be used for the animated plays. Three arranged playing fields are at the disposal of the customers. But the direction declines any responsibility in the event of accident. The children will have to always be under the monitoring of their parents.

12° - DEAD GARAGE

It could be left of material nonoccupied on the ground only after agreement of the direction and only with the site indicated. A royalty whose amount will be posted at the office will be due for the dead garage.

13° - CHIEF OF CAMP

It is responsible for the order and of the good behavior of the camp, it has the duty to sanction serious deficiencies with the payment and if necessary, to expel the authors. A book or a special box intended to receive leks complaints is held with the provision of the users. The complaints will be taken into account only if they are signed, will be dated, as precise as possible and referring to facts relatively recent.

14° - CARPARK OF NIGHT

The carpark of night is at the disposal of the customers. There however, the direction declines any responsibility for flights or degradations being able to be made.

15° - INTERIOR GATE OF ENTRY

It is open 7:30 to 23:00. The side wicket remains open day and night permanently.

16° - MAIL

The mail is distributed to the Reception Office, 10 a.m. to 8 p.m. Only one daily lifting takes place with 16:30, excluded Saturdays, with 12:00.

17° - TELEPHONE MESSAGES

The telephone messages are posted with the reception, excluded the emergency messages which are given directly to the interested parties.

18° - BARBECUE COLLECTIVES

With the provision of the customers provided that this one is in conformity strictly with the security measures in force.

19° - ALSO, CAMPERS!

Collaborate maintaining the order and the safety of the camp, by holding clean the turn of your tents or caravans, while making respect the good behavior and good mood, by announcing to the office all

that could harm your peace, like with the good performance of the camp

We with pleasure accept any idea or suggestions likely to give to your stay an additional approval.

II - PARTICULAR CONDITIONS

The use of the barbecues is authorized only on the zones arranged and envisaged for this purpose: NOT BARBECUE. The occupancy rate of rented surface will not have to exceed 33%, that is to say 33m², car included/understood. The SHORTS and the BERMUDA SHORTS are prohibited in the enclosure of the swimming pools.
